A. 2019 Election Qualifying Fees

According to the election laws of the State of Georgia (Reference O.C.G.A. §21-2-131), municipalities are required to publish the qualifying fees for each office in an election year.

Qualifying fees for nonpartisan municipal offices in Georgia are 3% of the previous year's gross salary for the office and are to be set and published no later than February 1st of each year in which there is a regular election. These fees will be published in the MDJ newspaper and posted on our website.

The qualifying fee for Mayor is \$1,080.00 The qualifying fee for Council Members is \$432.00

A. 2000 Ford F-150 XL Donation

B. Sherwood Street Manhole Replacement

This project will include:

- Remove and dispose of existing failed concrete
- Remove and dispose of steel plate
- Supply and install new 12 x 6 concrete inlet and top with ring and cover.

The funds will be disbursed from the SPLOST account # 335-4200-54-1403 (Sidewalks).

C. Austell Streetscapes Ph.2

It is the recommendation of Public Works Department to accept and approve Austell Streetscape Phase 2- Added poles for the Parking Lot at Jefferson and Spring St.

This project will include:

- New City Standard Pole and LED Fixture on Existing Base 2 poles @ \$5,100 EA for a total of \$10,200
- Installation of New Fountain, Anchor Bolts, and Lighting Assembly only where the existing Light poles are currently located - 2 Locations @ \$1,400 EA total of \$2,800

Total for adding lights to the Parking lot at Jefferson and Spring St. is \$13,000. The funds will be disbursed from the contingency funds.
