# **JOB SUMMARY**

Performs a variety of semi-skilled and skilled tasks supporting maintenance work, and operates a variety of equipment on the construction, operation, repair, maintenance, and replacement of City Street and storm drainage facilities and systems.

# **ESSENTIAL FUNCTIONS**

#### **Erosion, Pollution, and Sedimentation Control**

Performs soil erosion inspections.

Document inspections with photographs, comments and/or notes.

Confer with management on the issuance of stop work orders, notice of violations, and citations to soil erosion violators.

Ensure the proper maintenance of equipment and tools by cleaning and checking equipment and tools after use.

Drive trucks of various sizes and weights in the loading, hauling, and unloading of various equipment, gravel, and sand.

Performs routine inspections and preventive maintenance on assigned equipment and refers defects or needed repairs to supervisor.

Performs required labor involved in construction and maintenance projects as part of crew, including pavement cutting, ditch digging, manhole and catch basin cleaning, main and pipe repair, laying and backfilling.

#### **Stormwater Management**

Performs inspections of the storm drainage system and appurtenances throughout the City of Austell.

Conducts annual inspections of post construction Best Management Practices, such as detention ponds, for maintenance needs.

Conducts dry weather screening of storm drain outfalls for illicit discharges and illegal connections and performs water quality testing as required.

Conducts inspections at critical construction stages and following rain events, including temporary and long-term water quality and quantity practices.

Document inspections with photographs.

Recommends stormwater enforcement actions to the Supervisor when violations are found.

Monitors water quality based on project needs and design consideration. Monitor changes in water quality standards, practices and techniques and recommend activities.

Inspect and enforce all buffer requirements.

Inspects for illicit discharge detection and elimination, dry weather screening and water quality monitoring.

Performs other duties as required.

# MINIMUM QUALIFICATIONS

High school diploma or GED; equivalent combination of education and experience.

Valid Georgia drivers' license.

Level 1B, Advanced Fundamentals Certified Inspector certification. (preferred)

# **PHYSICAL DEMANDS**

While performing the duties of this job, the employee is regularly required to use hands and/or fingers to handle, feel, or operate objects, tools, or controls in addition to reaching with hands and arms. The employee frequently is required to stand while talking/listening. The employee is frequently required to walk, sit, climb, or balance, stoop, crouch, crawl, and smell.

The employee must frequently lift and/or move up to twenty-five (25) pounds and occasionally in and/or move up to one hundred (100) pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception and the ability to adjust focus.

# WORK ENVIRONMENT

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee regularly works in outside weather conditions. The employee frequently works near moving mechanical parts and is frequently exposed to wet and/or humid conditions and vibration. The employee occasionally works in high, precarious places and is occasionally exposed to fumes or airborne particles, toxic or caustic chemicals and risk of electrical shock. The noise level in the work environment is usually moderate to loud.
